## <u>Call to Order – Roll Call of Membership</u>

The meeting was called to order by Mayor Jay McGowan at 7:00 p.m. The Pledge of Allegiance was recited. Members present were Arthur Scott, Lindsey Ozbolt, Ron Spears, Mickey Holz and Ken Ratliff. Other members present were City Administrator Robert Omans, City Attorney Alexandra Kenyon and City Clerk Kathi Swanson. Steven Harper was absent. *Mayor McGowan excused Steven Harper as he had previously notified the council he would be absent.* 

### Approval of the Meeting Agenda

1. Mayor McGowan announced Arthur Scott will be with the City Council for one more month through August 2016.

Mayor McGowan announced the Planning Commission and the UGA Committee will hold a public meeting on 08/02/16 at 6:00 p.m. to review the County Growth Management document to determine and rationalize the projected 20-year growth.
 Mayor McGowan announced the City is taking nominations for the Pangrazi Award through July 29<sup>th</sup>.

### Consent Agenda

A 1110tion was made by Lindsey Ozbolt and seconded by Arthur Scott to approve the Consent Agenda with the amendment to the Study Session notes to "Lindsey Ozbolt stated, in regards to the draft regulations in front of council that the sale of cannabis is permitted outright and the planning process is not required". The Consent Agenda includes the amended notes from the Study Session held on July 12,2016; the minutes of the July 26,2016 Regular City Council Meeting; vouchers and checks numbered 037500 through 037552 in the amount of \$166,924.69; and payroll vouchers in the amount of \$66,081.82. Motion carried unanimously.

## Citizen Comments on Non-agenda Items

• Reminded the Council there is a Port District Town Hall Meeting on 08/11/16 at 7:00 p.m.

• Commented the Council, Staff and Administration is much better than in past years and reminded all to be civil and cordial to each other.

### Public Hearings

a. Continued Closed Record Public Hearing: Ordinance #1452 - Limiting the number of animals: Two versions of the ordinance were provided by staff and legal counsel; Council discussed retroactive versus not retroactive enforcement. The amended ordinance also removed the word "Fowl" from the title as directed by Council. Council also discussed the specific definition of four animals due to the phrase "four animals of anyone kind" being changed to "four animals" in the most recent version. A motion was made by Lindsey Ozbolt and seconded by Mickey Holz to approve Ordinance 1452 with the deletion of the phrase "WHEREAS, the City intends for this ordinance to apply/not to apply retroactively" and to add "of anyone kind" after "limits a resident to four animals {of anyone kind] in the first paragraph of the Ordinance, as well as at the end of the sentence in Section 1 (B). Motion carried unanimously.

b. Public Hearing: Ordinance #1453 relating to marijuana producers, processors and retailers: Administrator Robert Omans presented a staff report asking the council to approve the proposed ordinance based on changes in the State regulations. Council discussed the buffer zones in relation to parks and playgrounds. Council noted the error in numbering under 17.10.030 C as 1,2, and 4. A motion was made by Ron Spears and seconded by Mickey Holz to approve Ordinance #1452 as presented with corrections to 17.10.030 C to change "4" to "3", repealing Ordinances 1428 and 1429. Ron Spears, Lindsey Ozbolt, Arthur Scott and Mickey Holz voted yes. Ken Ratliffand Christine Simpson voted No. Motion carried.

## Public Appearances

Amy McGuffin - Director of Tourism - Kittitas County Chamber of Commerce

• Reported the visitor center is above track with 804 visits to date; there were 754 visitors reported at this time last year.

• Reported brochure racks are up at City Hall, the Public Bathrooms, Mac-a-Bees and the Horse Park; 375 brochures have been taken from those racks in the last week.

• Reported the video on Facebook has had an additional 95,000 views for a total of 162,000 views in the past 60 days.

• Reported the Chamber is conducting research on how to balance residing in Cle Elum with tourism visits to the City.

In addition, there will be workshops at the Upper Kittitas County Courthouse on 08/16116 and 08118/16 from 5:30 to 7:30, as well as workshops in Ellensburg and Roslyn at later dates.

• Reported the Kittitas County Capital Improvement Project grant applications have been reviewed; the application for the Horse Park fence, as well as the Coal Mines Trail Commission application have been approved for funding. *Ken Ratliffformally recognized and acknowledged the hard work put into the ClP Applications by Mayor McGowan, Robert Omans, Lauren Shuck, Craig Mabie and Kathleen Horner.* 

• Reported she represented the Cle Elum Downtown Association at the Washington Main Street Conference in Port Townsend. Lindsey Ozbolt also attended the Conference on behalf of the City Council and the Chamber of Commerce.

Gary Berndt - Tree City USA: Berndt described the four required conditions to reestablish a Tree City and asked the Council for approval to move forward with the process. The conditions are: Establish a Tree City Board; adopt an Ordinance establishing a Tree City; budget \$2.00 per capita as a line item in the Current Fund of the budget; join the Arbor Day Foundation, observe Arbor Day and create a Proclamation. An Ordinance was adopted in 1995 and the City is already a member of the Arbor Day Foundation. Council unanimously approved the establishment of a Tree City and directed staff to publish for Volunteers for the Tree City Board.

Softball Tournament as presented with the additional condition they obtain any necessary certificates from tI,e COl/nty Health Department. Motion carried unanimously.

c. Airport Contract Agreement with Granite Construction - Robert Omans: Omans infonned the Council the draft document of the Airport Apron Project will be completed and signed at the Pre-construction meeting on 08/02/16 and asked for Council to authorize the Mayor's signature. A motion was made by Ken Ratliffand seconded by Mickey Holz to authorize the Mayor to sign the Airport Contract Agreement with Granite Construction once the contract documents are complete to the satisfaction of Mayor and Staff. Motion carried unanimously.
