# ORDINANCE NO. 1/96

An ordinance of the City of Cle Elum, Washington, annexing certain real property commonly known as the Bullfrog UGA and as legally described in Exhibit "A" hereto, and depicted on the map at Exhibit "B" hereto and designating the land use and zoning of the annexation area and establishing an effective date of the annexation.

WHEREAS, RCW 35.13.015 authorizes second class cities to utilize the election method of annexation; and

WHEREAS, the City of Cle Elum is a second class municipal corporation organized under the laws of the State of Washington, located in Kittitas County, Washington; and

WHEREAS, the lands lying within the corporate limits of the City are subject by law to assessment and taxation for, among other things, bonded indebtedness of the City, if any; and

WHEREAS, on June 23, 1998 the Cle Elum City Council established, by City of Cle Elum Resolution No. 6-23-98-1 an Urban Growth Area ("UGA") of the City of Cle Elum, which includes the Bullfrog Flats area immediately west of the City; and

WHEREAS, on December 22, 1998, the Kittitas County Board of Commissioners adopted Ordinance 98-24 amending the County Comprehensive Plan to establish the Bullfrog Flats area immediately west of the City as the City's Urban Growth Area; and

WHEREAS, The City has created a Bullfrog subarea plan addressing planning for the proposed annexation area as well as Planned Mixed Use zoning for the area owned by Trendwest Investments, Inc., density-restricted single family zoning for the area known as the Peare property and Public Reserve zoning for property owned by Puget Sound Energy where the existing power substation is located; and

WHEREAS, Puget Sound Energy, the owner of certain property that is the subject of this Resolution, has indicated it does not object to annexation; and

WHEREAS, the Cle Elum City Council determined that it would serve the best interests and general welfare of the City to submit, to the voters, the proposition to annex portions of the Bullfrog Flats UGA as shown and described on Attachment A hereto into the City of Cle Elum subject to adoption of the planning and zoning shown in the Bullfrog subarea upon annexation, and which property shall be assessed and taxed at the same rates and on the same basis as property currently within the City limits; and

WHEREAS, the City submitted a Notice of Intent to Annex with the Kittitas County Boundary Review Board concerning the proposed annexation; and

WHEREAS, a period of forth-five (45) days elapsed without the Kittitas County Boundary Review Board's jurisdiction having been invoked and pursuant to RCW 36.93.100, the annexation was deemed approved insofar as the Kittitas County Boundary Review Board portion of the process was applicable; and

WHEREAS the City of Cle Elum called for an election by the electorate of the annexation area on the questions of whether said unincorporated area should be annexed into the city, with adoption of the planning and zoning specified for the area as Planned Mixed Use, and densityrestricted Residential and Public Reserve, and subject to assumption of city indebtedness; and

WHEREAS, on May 20, 2003, the question of the annexation was put to the vote of the six eligible voters residing in the annexation area; and

WHEREAS, Kittitas County certified the results of the election as five votes having been cast, all in favor of the annexation proposal, and

WHEREAS, the City Council finds that it is in the best interests of the health, safety, morals and general welfare of the citizens of the City and the citizens of the annexation area for the annexation area to be annexed to the City, NOW THEREFORE,

The city council of the city of Cle Elum, Washington do ordain as follows:

<u>Section 1</u>. The real property that is contiguous and adjacent to the present corporate limits of the City of Cle Elum as legally described in Exhibit "A" attached hereto and depicted on the Map attached hereto as Exhibit "B", should be and hereby is annexed to the and made a part of the City of Cle Elum.

<u>Section 2</u>. Planning and zoning of the annexed area shall be specified as Planned Mixed Use, and density restricted Residential and Public Reserve. The City Planner Director is directed to insert the appropriate zoning for the annexed area on the official zoning map of the City when this Ordinance becomes effective.

<u>Section 3.</u> The real property annexed hereby shall be assessed and taxed at the same rate and upon the same basis as the land now located kin the City of Cle Elum, Washington.

Section 4. The area annexed hereby shall become a part of the City of Cle Elum, Washington, and this Ordinance shall take effect and be in force on June 15, 2003.

<u>Section 5.</u> The City Clerk is hereby directed to cause a summary of this ordinance to be published in a newspaper of general circulation in the City and the City's official newspaper. The City Clerk is further directed to file a certified copy of this ordinance with the Board of Commissioners for Kittitas County.
