Municipal Engineering Services

The City of Cle Elum is inviting Statements of Qualifications (SOQ) from firms interested in providing professional engineering design, bidding, planning, construction observation and funding administration services for the following projects:

Highway Safety Improvement Program (HSIP) funded project: Signalized Intersection Safety Improvement at W First St and Hartwig Blvd. The project includes installing signal upgrades including protected/permitted left turn phasing, radar detection, visibility enhancements, ADA upgrades, and miscellaneous improvements. The total project cost for professional services and construction is approximately \$333,000.

Surface Transportation Block Grant (STBG) funded project: First Street and Oakes Avenue Resurfacing. The project includes a mill and overlay on First Street from Oakes Avenue to Peoh Avenue and along Oakes Avenue from First Street to Second Street, and pavement markings. The total project cost for professional services and construction is approximately \$825,900.

Transportation Alternatives (TA) funded project: Park Street Pedestrian Corridor Feasibility Study. The project includes preparing a feasibility study for pedestrian and bicycle access. The total project cost for professional services is approximately \$53,000.

Transportation Alternatives (TA) funded project: Stafford Avenue Sidewalk and SR 903 Speed Camera. The project includes constructing new sidewalk on the east side of Stafford Avenue and a road crossing to the Coal Mines Trail trailhead. Additionally, an automated traffic safety camera will be installed on the south side of SR 903 across from Denny Avenue. The total project cost for professional services and construction is approximately \$186,600.

All projects are anticipated to begin by June 2, 2025 with completion by September 30, 2026. It is anticipated the contract type will be cost plus fixed fee.

Statements of Qualifications for this solicitation shall be limited to twenty (20) pages excluding a one-page cover letter and front and back covers (if used). Selection criteria will include key personnel; firm experience; ability to meet schedule; familiarity with WSDOT/FHWA standards; LAG Manual and NEPA processes; in-house expertise; and past performance/references. Statement of Qualifications will be evaluated on a competitive basis using the above criteria. The jurisdiction will score the received Statement of Qualifications and conduct interviews.
