To: the Mayor and City Council of Cle Elum, and City of Cle Elum Planning Department,

I am writing in support of the variance requested by Whole Health Pharmacy (VAR 2025-001).

I think it is healthy for any community to have a choice of pharmacy, and healthy for our society to support independent pharmacies. The Whole Health Pharmacy principals have a good proven track record of competent, conscientious service at their present Ellensburg store.

The availability of drive-up window service increases accessibility to customers, some of whom may be sick or disabled. This is a service not currently available in our community, as Safeway does not have drive-up service, and the Safeway pharmacist today confirmed to me that they have no plans to install a drive-up window. Across the alley from where I presume the drive-up window is planned is a parking lot. I don't know who owns it, but I note it also has access from Railroad Street. I would expect that it would be rare for there to be a long line of vehicles waiting for drive-up window service.

Should we suffer another pandemic in the future, that availability of minimal-contact drive-up service would become even more important.

The pharmacist at Safeway also indicated (speaking for himself, not for the corporation), that he felt that in the past, when there was a second pharmacy in town, competition was good for both entities. He regrets the times when his customers have long waits. He estimated, based on past experience, that Safeway would have to reduce staffing by one or two people if a second pharmacy opened here. But I will state the obvious—that the second pharmacy would be an employer so there would be no net loss of jobs to the community.

For these reasons, I strongly support issuance of this variance,
