PROJECT DESCRIPTION: The City of Cle Elum has received an application for preliminary plat approval of Bullfrog Flats Phase P-4, a residential subdivision within the approved Bullfrog Flats Master Plat and Development Agreement area, together with associated minor modifications. The proposal would create 152 single-family residential lots, along with associated streets, utility infrastructure, open space tracts, drainage facilities, and related improvements necessary to serve the phase and support continued development of the Bullfrog Flats community.
